ORDINANCE NO. 1449  
(Special)

AN ORDINANCE AMENDING ORDINANCE NO. 922,  
AS AMENDED BY ORDINANCE NO. 1191, NO. 1222,  
AND NO. 1417 BY ANNEXING TO AND BRINGING  
WITHIN DIVISION 6 OF GENERAL SANITARY  
SEWER DISTRICT NO. 4, A TRACT OF LAND,  
DETERMINING THE BOUNDARIES OF GENERAL  
SANITARY SEWER DISTRICT NO. 4 AND  
DIVISION 6 THEREOF, AND DECLARING AN  
EMERGENCY.

WHEREAS there is within the City of Hood River  
those premises along the Western boundaries which are just  
North of and adjacent to Division 6 of General Sanitary Sewer  
District No. 4 and the same can properly be served by an  
extension of the boundaries of Division 6 of General Sanitary  
Sewer District No. 4, therefore,

THE CITY OF HOOD RIVER ORDAINS AS FOLLOWS:

Section 1: That Ordinance No. 922 as amended by  
Ordinance No. 1191, 1222, and 1417, setting forth the boundaries  
of General Sanitary Sewer District No. 4 and Division 6 thereof  
be and the same is hereby amended to include within said  
Division 6 of General Sanitary Sewer District No. 4 that area  
in the City of Hood River, County of Hood River, State of  
Oregon, described as:

The East 152.29 feet of the West 347.20 feet of  
the South 171 feet of Lot 19, ADAMS PARADISE  
ACREAGE, a subdivision of the Northwest quarter  
of Section 35, Township 3 North, Range 10 EWM

Section 2: That the creation and activation of  
Division 6 of General Sanitary Sewer District No. 4 of the City  
of Hood River as set forth in Ordinance No. 1417 is extended  
by this ordinance to include the area described in Section 1 above  
the same as though it was included in Ordinance No. 1417.

Section 3: That this ordinance is necessary for the  
immediate preservation of the public health, peace and safety

of the inhabitants of the City of Hood River so that sewerage service may be furnished to the above described area at the very earliest possible date, therefore, an emergency is hereby declared to exist and this ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor or President of the Council.
