A RESOLUTION SETTING RATES FOR GARBAGE COLLECTION

WHEREAS, the City Council received a presentation on the reasons for increased solid waste collection rates at their August 12, 2019 Regular Meeting; and

WHEREAS, the City Council has determined that the proposed rates charged by Hood River Garbage for solid waste collection as represented in Exhibit A are just and reasonable and adequate to provide necessary collection service; and

WHEREAS, the Hood River Garbage Franchise Agreement specifies that setting rates for solid waste collections is done by resolution.

NOW, THEREFORE BE IT RESOLVED by the Hood River City Council that the rates in Exhibit A shall apply effective September 1, 2019
