A RESOLUTION SETTING RATES FOR GARBAGE COLLECTION


WHEREAS, the City Council received a presentation on the reasons for increased solid waste collection rates at their July 25, 2022 Regular Meeting; and

WHEREAS, the Hood River Garbage Franchise Agreement specifies that setting rates for solid waste collections is done by resolution.


NOW, THEREFORE BE IT RESOLVED by the Hood River City Council that the rates in Exhibit A shall apply effective September 1, 2022
