"RESOLVED that FIRST NATIONAL BANK OF OREGON, PORTLAND, and THE UNITED STATES NATIONAL BANK OF OREGON at any one or more of its offices or branches, be and it is hereby designated as the banks of and depository for the funds of this Corporation, which may be withdrawn on checks, drafts, receipts or advices of debit given or signed in the corporate name in the manner as stated below:

make and enter into any and all agreements, including, but not limited to, Special Depository Agreements and Arrangements with reference to the manner in which, the conditions under which or the purposes for which funds, checks or other items of

this Corporation may be deposited, collected or withdrawn; to delegate to others such authority in connection with any Special Depository arrangement that may be deemed appropriate, and to do and perform such other and further acts and things in connection with or pertaining to the establishment of any account or the transaction of any banking business with said Banks as they may consider proper.

"RESOLVED FURTHER that the authority hereby conferred upon the above named persons shall be and remain in full force and effect until written notice of the revocation thereof shall have been delivered to and received by the Banks at the branch (es) or office (s) where such account (s) is (are) maintained."
